The purpose of this page is to describe how the site is managed with reference to the processing of personal data of users who consult it, who will be treated according to lawfulness, correctness, relevance and non-excess.

Please note that the information is provided only for the aforementioned site and not for other websites that may be consulted by the user via any link.

1) Why you receive this communication

JK GROUP S.P.A., as Data Controller, wants to inform you on what data it collects and with which methods, so as to ensure the respect of your rights and your fundamental freedoms, with particular reference to the privacy and security with which the data are processed.

2) Object of processing

The processed data refer to:

- Data collected automatically. The computer systems and the applications dedicated to the functioning of this website detect, during their normal operation, some data (the transmission of which is implicit in the use of Internet communication protocols) potentially associated with identifiable users. The collected data includes the IP addresses and the domain names of the computers used by the users connecting to the site, the addresses in the Uniform Resource Identifier (URI) notation of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (success, error, etc.) and other parameters concerning the operating system, the browser and the computer environment used by the user. These data are processed, for the time strictly necessary, for the sole purpose of obtaining statistical information on the use of the site and to check its regular operation. The provision of such data is mandatory as it is directly connected to the web browsing experience.
- Data provided voluntarily by the user. We will retain the contact information you provide (for example, name, surname, address, telephone number, e-mail, country of residence, telephone number) when you create an account on the site, buy a product and / or participate in our competitions or promotions and / or calling for assistance. Your payment and billing information. We will keep the payment and billing information you provide us (for example, credit card number, zip code and address when you purchase a product, for the purposes of managing your purchase orders and shipping products). If you request it, we can also keep the payment and billing information in order to make future purchases of products easier. Information on the use of the site. Your use of our sites involves the processing of data on the browser and device you are using and your IP address (this is the number that identifies a specific device on the internet and that is necessary for your device to communicate with the sites). We can analyze from which site you came from, what you did and did not accomplish on our site. We may collect any information you may have provided via the email address info@jk-group.com or by filling out the appropriate form in the section 'work with us', the processing of which is subject to your express and unequivocal consent following reading of the dedicated information.
- Cookies. The site does not use / uses technical / profiling cookies of the first part / third parties which may collect user browsing data, whose provision is mandatory for technical cookies to allow navigation while it is optional and takes place through the expression of a free and informed consent regarding profiling and third-parts cookies. Cookies work in order to analyze the effectiveness of the site and make it easier and more intuitive over time. For more information, a special cookie policy is available on this site in the dedicated section.

3) <u>Legal basis for the processing</u>

The legal basis of such processing recognizes in its express and unequivocal consent in the legitimate interests of the owner, in the fulfillment of legal and / or contractual obligations (Article 6 GDPR).

4) For what purposes we use your personal data

The collection and processing of personal data will be carried out exclusively for purposes strictly connected and instrumental to the fulfillment of obligations relating to relationships with our company (to: process and manage your orders, send the products you purchased, provide the necessary assistance post-sale, manage the return procedure of the products purchased) and / or to process requests promoted by e-mail, as well as possibly for obligations and obligations provided for by laws, regulations and community regulations or by instructions given by authorities legitimated by the law and by supervisory and control bodies and for anonymous and aggregate statistical purposes.

With explicit consent:

- Send newsletters and / or e-mail communications relating to initiatives, events or promotions that may be of interest to you;
- Analyze your usage, preference and consumption data of our products to improve our approach to you and our customers in general, through automated treatments that include profiling. We do this in order to make better decisions about services, advertising, products and content that are based on greater awareness of how our customers use our services and to ensure a more personalized experience. To this end we may also collect the identifier for advertising your mobile device (IDFA Identifier for Advertising for iOS devices and AAID Google Advertising ID for Android devices) to enable us to always provide targeted and relevant ads based on your preferences and your interests.

5) How long we store your personal information

Personal Data collected for purposes related to the execution of a contract between the Owner and the Customer, as well as to process the promoted requests will be retained until the execution of the contract is completed, but no later than 10 years.

The data collected for the purpose of promotion and direct marketing will be retained until the revocation of consent and, in any case for a period not exceeding 2 years.

The data collected for the purpose of direct profiling will be retained until the revocation of consent and, in any case for a period not exceeding 12 months.

The Data Controller may be obliged to keep Personal Data for a longer period in compliance with a legal obligation or on the order of an authority, or for its own legitimate interest in order to protect its own right, including in court.

At the end of the retention period the Personal Data will be deleted. Therefore, at the end of this term the right of access, cancellation, rectification and the right to data portability can no longer be exercised.

6) The security of your personal data

Your data will be processed using instruments that guarantee confidentiality, integrity and availability. The processing is carried out on paper and through computerized and / or automated systems and will include all the operations or set of operations envisaged in art. 4 of the GDPR and necessary for the treatment in question, including the communication with the subjects assigned to the processing itself. The data in question will not be disseminated; instead, they will be or may be communicated to public or private subjects operating within the scope of the purposes described above.

7) Who can access your personal data

Only authorized persons may access your data in the context of the duties assigned by the Data Controller, possibly also to employees and / or collaborators of infragroup companies such as Dover Corporation.

For the purposes indicated, the data - or some of them - may also be accessible or may be disclosed to persons whose right to access their personal data is recognized by provisions of law or secondary or community legislation.

8) Where your personal data are stored

The management and conservation of your personal data will be made on paper, duly stored in special archives locked and / or on servers located within the European Union of the Owner and third-parts companies in charge and duly appointed as Data Processors. The data will not be transferred to outside the European Union.

9) <u>Is it obligatory to consent to the provision of your data?</u>

The transmission of your navigation data is mandatory to continue browsing on this site.

The provision of data for the purpose of direct marketing and / or profiling is optional.

The Data Controller does not require any other data, but some of your personal data and identification data may be provided by you on the occasion of a request sent by mail to info@jk-group.com

10) What are your rights in relation to the GDPR?

According to the provisions of the GDPR, JK GROUP S.P.A. guarantees the following rights:

- obtain confirmation of whether or not personal data processing is in progress for you and in this case, obtain access to personal data (Right of access, Article 15);
- obtain the correction of inaccurate personal data concerning you without undue delay (Right of Rectification Article 16);
- to obtain the cancellation of personal data concerning you without undue delay, the Owner is obliged to cancel your personal data without undue delay, if certain conditions are met (Right to be forgotten Article 17);
- obtain the limitation of treatment in certain cases (Right to limitation of treatment Article 18);
- receive, in a structured format, in common use and readable by an automatic device, the personal data you have provided to us and possibly transmit them to another Data Controller (Data portability right, Article 20);
- oppose at any time, for reasons connected with your particular situation, to the processing of personal data concerning you (Right to oppose art 21);
- to receive without undue delay notification of the violation of personal data suffered by the Data Controller and / or the Data Controllers if said violation represents a threat to the rights and freedoms of the interested part (Article 34);
 - revoke the consent expressed at any time (Conditions for consent Article 7).
